During his tenure at Temple, Professor Zuckerman served as Associate Professor of Instruction, Academic Director of the Center for Risk, Resilience, and Sustainability, and led the MBA concentration in Enterprise Risk Management. He is also the visionary behind the University's ERM initiative including its ERM Conference (2018 - 2020), which was a mustattend event for forward-thinking leaders in risk management, insurance, and alternative risk financing. His teaching portfolio included undergraduate, graduate, and Executive MBA programs, where he integrated real-world insight drawn from decades of experience to shape the next generation of risk and insurance leaders.

Michael recently transitioned into a new chapter in his professional life. After many rewarding years on the faculty at Temple University's Fox School of Business, he now holds the title of Emeritus Associate Professor.
